## Notification of Results of Bidding



**Invitation for Bids No: ADB-EDC-GRP-P2-2022**

EDC has received ADB's No-objection to the Bid Evaluation Report of the Grid Reinforcement Project (Design, Supply, Installation and Commissioning of 230kV and 115kV Outdoor Substations), Loan No. 3967-CAM (COL) dated November 08, 2023 for awarding the contract to bidder No.2: Joint Venture of Power China Fujian Electric Power Engineering Co., Ltd. and SEPCO Electric Power Construction Corp in the amount of **US Dollars 38,425,028.20 (Thirty-Eight Million Four Hundred Twenty-Five Thousand Twenty-Eight US Dollars and Twenty Cents) excluding taxes and duties.**

1. 14 (fourteen) firms participated in the bid (the deadline of bid submission: October 26, 2022). Bids were opened on the same day, and the name of bidders and their proposed prices as read out in the bid opening are as show in Attachment 1.
2. 4 (Four) proposals were determined as responsive bids to the Evaluation and Qualification Criteria set out in the bidding document.
3. The information showing (a) name of each bidder who submitted a bid; (b) bid prices as read out in the bid opening; (c) name and evaluated prices of each bid that was evaluated; (d) name of bidders whose bids were rejected and the reasons for their rejection; and (e) name of the winning bidder, and the price it offered are attached as Attachment 1.

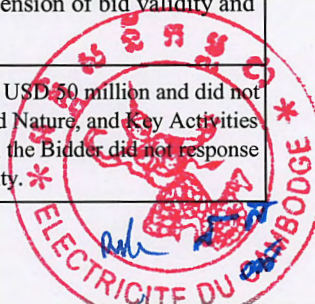
